What is the FIDA-IDD Plan Program?

FIDA-IDD is a new program in New York State for adults with intellectual and developmental disabilities who have Medicare and Medicaid.

With FIDA-IDD, you get the benefits you have now all in one managed care plan. You get:

- Medicare Part A including hospital care and home health services
- Medicare Part B including emergency room visits, doctor visits, and wheelchairs
- **Medicare Part D** prescription medicines
- Medicaid including home care, behavioral health services and some prescription medicines

If you choose the FIDA-IDD plan, you will have:

- One card for all your care and medicines
- No additional premiums, deductibles or copays for your Medicare/Medicaid services once you enroll in the FIDA-IDD

You will have the full support of a Care Team

As a FIDA-IDD plan member, you will have your own Care Manager and care team, called an Interdisciplinary Team (IDT).

Your IDT will include you, your Care Manager and your primary providers of Office for People With Developmental Disabilities (OPWDD) services.

You can also include a family member, friend, social worker or anyone else you choose on your team.

How will an IDT help me?

An IDT means that your doctors and other care providers can work together to make sure you get the services you need, get to your appointments, and get your medicines.



With a FIDA-IDD Plan, you will have the full support of your IDT to help you stay as healthy and independent as possible.

- Individuals who are eligible for Intermediate Care Facility (ICF-IID) level of care or are enrolled in the 1915(c) OPWDD Comprehensive Waiver.
